Sub: Guidelines for enrolling License and Non-License holders in single DAESI Batch

The NTIs/ATMA are facing difficulty to mobilize the 40 licensed input dealers to start a CSPS batch. To train the remaining license holders of agri-input dealers, it is decided to allow enrolling both license holders and non-licenses in a single DAESI Batch. These batches will be called as '**combined**' batches for administrative purpose. Following guidelines are issued for starting a combined batch of DAESI.

1. The combined batches provision can be allowed from the financial year 2021-22 batches only and the previous financial year batches of CSPS/SF cannot be converted to combined batches for administrative reasons.
2. Already approved batches of 2021-22 may be converted to combined batches by the NTIs with an intimation to MANAGE/SAMETIs
3. The NTIs will have choice to propose either CSPS or Self-Finance or the combined batches or all three types of batches in a single NTI.
4. While sending the proposals of combined batches for approval, the NTIs should enlist the license holders in the beginning along with their license number in a separate column followed by candidates without licenses.
5. The NTIs should collect an amount of Rs. 10,000/- from license holders and Rs. 20,000/- in case of non-license holders.
6. The SAMETIs are requested to verify the licenses of the agri-input dealers in combined batches before sending the proposals. Accordingly, the subsidy amount will be released to SAMETIs for the number of license holders enrolled in that batch.

7. Separate facilitators have to be recruited to manage each batch of DAESI program in an NTI. A facilitator can organize only one batch of DAESI at a time.
8. The facilitators of combined batches shall enter the data carefully in MIS as wrong selection of options of type of batch and type of candidate etc. will lead to problems in MIS database. A separate orientation on data entry in MIS will be arranged for all facilitators by MANAGE.
